On-Wall Tethered Charge Points:

The OZEV grant (also known as the Electric Vehicle Homecharge Scheme or 'EVHS') offers EV drivers 75% off the total cost of their new smart home charger, up to a maximum £350 (inc VAT).

Landlords buying charge points for rental properties can apply for funding for up to two charge points per household. Maximum of 200 grants for residential properties and 100 grants for commercial properties per financial year.


Renters/tenants may also apply.

To qualify for funding, you must have the following:

- Off-street parking (e.g. a driveway or a garage)
- · An approved pavement channel fitted
- The charger must use smart technology (e.g. Monta App)
- The charger must be installed by an OZEV approved installer.


